Your esteemed company should strictly and continuously comply with the requirements in any laws, conventions, rules, or regulations in respect of, including but not limited to, declaration, packaging, labeling, carriage, or handling of Hazardous Cargo, and should honestly and accurately make declaration of Hazardous Cargo in accordance with the said requirements as well as the requirements made by CUL, the carrier, or our or the carrier's agent prior to delivery of cargo to us at our designated depots/terminals.

With effective from 1st September 2019, your esteemed company, as either the Shipper, Consignee or Notify party, will be charged at **USD15,000** per container, as liquidated damages, due to your incompliance, non declaration, or failure to honestly and accurately make declaration of Hazardous Cargo, and we may, at our sole discretion, suspend or terminate the carriage of your cargo at any time and any place.

In addition to the said liquidated damages, your esteemed company shall be responsible for any costs, expenses, losses and damages arising therefrom or in connection therewith.
